COVID-19 Blanket Swing Bed Waiver

CMS has authorized hospitals to establish SNF swing beds payable under the SNF prospective payment system (PPS). This waiver will provide additional options for hospitals who have patients that no longer require acute care but are unable to find placement in a SNF. This waiver applies to all Medicare enrolled hospitals, except psychiatric and long term care hospitals that need to provide post-hospital SNF level swing-bed services for non-acute patients in hospitals, so long as this waiver is consistent with all state-level regulations.

Legislative Update: The Healthcare Workforce Resilience Act

The Healthcare Workforce Resilience Act (H.R. 6788/S. 3589) will help bolster the healthcare workforce in the United States by recapturing 40,000 unused visas and making these visas available to physicians and nurses. This bipartisan legislation has 25 cosponsors in the House and 20 cosponsors in the Senate. SHM members have already sent nearly 500 messages to their

Congressional leaders—but we need to continue to pressure our legislators to pass this important legislation.

Now more than ever, immigrant hospitalists are providing lifesaving and quality care. This legislation will both bolster our healthcare workforce while also reducing the existing green card backlog.
